APPROVAL TO USE MEGAMACS AUTOMATED MOBILE TANK CLEANING SYSTEM

Your letter reference JKP/DPR/MGM/05/2012 of July 2, 2012 on the above subject refers

- 2. In view of the successful tank cleaning exercise conducted between February 20 and June 28, 2012 on the NNPC-PPMC Tanks 102 & 107 at ESCRAVOS Terminal, using the Megamacs Automated Mobile System, and in consideration of your compliance with statutory and administrative requirements as well as established appraisal milestones, the Department hereby grants you final approval to deploy and use the equipment (Megamacs Automated Mobile Tank Cleaning System) in the Nigerian Oil and Gas Industry.
- 3. Please note that this approval is granted based on the technical efficacy/efficiency of the equipment and manpower capabilities you have demonstrated in the deployment of the facility in-country, and consequently the following conditions shall apply:
 - JKPEEZ Impex Company Limited shall ensure complete adherence to specific methodology as contained in the approved Environmental Monitoring Plan (EMP) for disposal of associated waste streams arising from the tank cleaning processes;
 - ii. Every waste stream from all process cycles shall be documented on a waste manifest which shall contain information such as the date, quantities, waste source etc. The waste consignment note for transport and transfer of wastes custody must also be documented

- and signed off by the appropriate parties where the disposal shall be through a third party.
- iii. Records of all wastes as required in items 3(i) and 3(ii) above shall be sent to the Department along with other analytical and monitoring information required by a condition of this authorization on a quarterly basis. The concurrent compliance shall form the basis for annual renewal of your Oil Industry Operational Permit.
- 4. Please note that there shall be no discharges from the authorized tank cleaning process to controlled waters. Therefore you are required to ensure proper containment of discharges from this authorized process to prevent environmental degradation as much as possible.
- 5. Finally, while the DPR has taken every precautionary measure before granting this approval, it is the responsibility of JKPEEZ Impex Company Limited to safeguard the local operational environment from any damage as a result of its activities. The Director of Petroleum Resources is therefore indemnified from any Health, Safety and Environmental (HSE) damages that might occur as a result of your operations.
